SIR Branch 47 Board Meeting

February 22, 2021

Meeting was called to order at 10:30 a.m. by Big Sir Doug Twitchell and a quorum was determined to be logged in.

Attendees: Doug Twitchell, Frank Ghazzagh, Rick Coburn, Jake Solomon, Alan Thomas, George Brown, Bob Gonzalez, Bill Stewart, Will Kaefer, Jim Kleiser and George Miller. Missing was Ned Lawrence. Visitors present were Ron Kosciusko and Mark Bosch.

Minutes from Board meeting of January 25, 2021 were moved for acceptance.

Corona Virus Updates: There have been no known afflictions of COVID-19 among our membership as far as we know. Several Board members have had their first vaccination and are awaiting the second one. Effects from the second vaccination are said to range from no reaction to fatigue and flu-like symptoms.

Prior to routine business, Ron Kosciusko spoke to follow up on the possible Commerce revision. He offered information that a test system has been set up and revisions are under consideration.

A Speakers WEB page, <u>speaker web page</u>, provided by Alan Baker from SIR State, includes a feature of calling up a speaker from another Branch's ZOOM presentation that can be used if our scheduled speaker fails to appear for program presentation. It can also be found at SIR State under Branch Resources.

Big SIR Report:

A call list for 2021 has been distributed to board members
It was confirmed that the annual audit report had been submitted to the Area Governor
It was confirmed that the branch roster was provided to the Area Governor and Regional Director

It was noted that a PDF version of the roster was forwarded to Area Governor and Regional Director but as previously discussed did not include telephone numbers or e-mail addresses of members. This decision was based on board's desire to retain membership privacy.

Little SIR Report:

Our speaker for February 23rd will be John Freeman who will make a Zoom presentation. The presentation is *How Dry I Ain't: Prohibition – the Ignoble Experiment that Failed*. Frank said that speakers are scheduled between now and May. Since programs are scheduled for Zoom presentation for an indefinite period, speakers will be checked for their adaptability prior to their presentations.

Treasurer's Report: No change in treasury status with figure of \$10,493.81 currently available.

Committee Reports:

Jake reported that currently the nominating committee will include him and Alan Thomas.

Big Sir and Little Sir positions will be filled for 2022.

Ned Lawrence has requested a switch in positions so that he will revert to Assistant Secretary and Alan will move into Secretary position. It is not known whether Ned plans to remain on the Board for 2022; both Secretary and Assistant Secretary are board positions. If Ned vacates his board position, then the Assistant Secretary position must also be filled for 2022.

Board Meeting continued from page 2) Old Business: Big Sir again raised the matter that the Sunshine function is vacant and he is holding materials given to him by Bill Donnelly on Bill's resignation. Frank Ghazzagh volunteered at this point to fill the Sunshine Coordinator position and there was brief discussion on availability of cards and that purchase of all materials is reimbursable. The Board extends its gratitude to Frank. A discussion ensued regarding storage of files within the confines of the Branch 47 Google drive account. Will Kaefer led a discussion regarding the original purpose of establishing cloud storage for the branch was to provide safe and ready access to critical raw files, such as the membership data base, the roster book, Tamaltalk, Form 28, and original historic documents like our chapter charter. These files should be in their original format like, Excel Word, Publisher, Quicken, etc. This is so such that if one of the current responsible person were to experience a serious health issue, there would be continuity of these important files. In switching from Dropbox to Google Drive, considerable additional data such as TamalTalk pdf files, BOD minutes, and individual membership applications have been uploaded which changes the original concept. It was not settled what Officer is responsible for managing this effort. Final paperwork has been completed with regard to being in compliance with COVID-1 outdoor regulations. SIR Branch 47 is doing everything that needs to be done as related to these activities and is documented by attachments concerning hiking, golf and bocce. Updated attachments are available with these minutes. Leaders for these activities are Jake Solomon for hiking, Ned Lawrence for golf and Kurt Heilman for bocce. SIR Outdoor Bocce Activities Branch BEC Resolution

RESOLVED, that all SIR sponsored bocce activities are henceforth approved by SIR Branch 47 provided:

such activities are not prohibited by an applicable order of the California Department of Public Health or Countyor Municipal Health Department, and all activities are conducted under written protocols in a strict compliance with all applicable State and Locally mandated mask, hand sanitizing, distancing requirements, and any other pertinent Health Related Requirements.

The Resolution and the written protocols must be passed by the Branch BEC and recorded in the Branch minutes.

Proposed Health safety measures:

Masks, or other facial coverings, are to be worn as long as California and/or Marin (or Sonoma) County requirements are in place. Bocce players choosing not to wear masks or face coverings will not be permitted to be part of the SIR group.

Social distancing shall be practiced, i.e. to maintain a minimum of 6 feet between bocce players whenever possible.

Any other activities before or after bocce are on each individual.

How will "special requirements" be communicated to Activity participants?

After approval by the Branch 47 BEC, the Bocce Chairman will provide an email copy to all members who have requested to receive bocce notifications.

The Bocce Chairman may suggest a lunch location that conforms to the dining regulations currently in effect.

Who will be responsible to assure "special requirements" compliance for activity members? Bocce Chairman or the member in charge of the specific bocce event.

SIR Outdoor Golf Activities

Branch BEC Resolution

RESOLVED, that all SIR sponsored golf activities are henceforth approved by SIR Branch <u>47</u> provided:

- (a.) such activities are not prohibited by an applicable order of the California Department of Public Health or County or Municipal Health Department, and
- (b.) all activities are conducted under written protocols in a strict compliance with all applicable State and Locally mandated mask, hand sanitizing, distancing requirements, and any other pertinent Health Related Requirements.

The Resolution and the written protocols must be passed by the Branch BEC and recorded in the Branch minutes.

<u>Activity:</u> This includes all golf activities within Area 8 (includes all of Marin County and parts of Sonoma, primarily the area of Petaluma) .which is scheduled by the Branch Golf Chairman. Due to the Corona Virus, some previously scheduled outings may have to change to comply with the State and Local County Health Department Requirements.

Proposed Health and Safety Measures: Sir Area 8 Golf Branches will follow and comply with all Federal, State, County, and Golf Course guidelines. This includes the wearing of masks as instructed by the County and Golf Course. Social distancing of 6 feet will be practiced in the warm up areas, practice greens, as well as on the Golf Course. There will be no social gatherings before or after the golf outing. Golfers will report to the Golf Course and check in with the pro shop as required 15 minutes prior to their tee time to pick up their key to the single golf cart. To safeguard the health of all Sir Members, we will communicate to all players, if you are running a fever, cough, or not feeling well; please do not participate in the golf activity at that time.

<u>Communications of Special Requirements:</u> The Branch Golf Chairman will obtain a written list of golf course specified safety measures and provide a copy to all golfers prior to the first group teeing off. This can be done by e-mail as well as a score cards for that foursome.

 Department of Public Health or County or Municipal Health Department, and
- (b.) all activities are conducted under written protocols in a strict compliance with all applicable State and Locally mandated mask, hand sanitizing, distancing requirements, and any other pertinent Health Related Requirements.

The Resolution and the written protocols must be passed by the Branch BEC and recorded in the Branch minutes.

Proposed Health safety measures:

- Masks, or other facial coverings, are to be worn as long as California and/or Marin (or other) County requirements are in place. Hikers choosing not to wear masks or face coverings will not be permitted to be part of the SIR group.
- Social distancing shall be practiced, as much as possible.
 Maintain a minimum of 6 feet between hikers whenever possible.
- Any other activities before or after the hike are on each individual. Restaurant lunches are not part of the hiking activity.

How will "special requirements" be communicated to Activity participants?

- When approved by the Branch 47 BEC, Chairman will provide a copy of this request to all Hike Leaders, and to all members who have requested to receive hike notifications.
- Hike Leaders will reiterate the health measures in the e-mail hike advisories with other hike details and directions. Hike Leaders will remind hikers of these rules at the beginning of the hike.
- 3. Hike leaders may suggest lunch locations that conform to dining regulations currently in effect.

Who will be responsible to assure "special requirements" compliance for activity members?

One of the most important and least known duties in the Marine Corps and in all the other US military branches is the Casualty Assistance Call Officer. Headquarters Marine Corps utilizes a nationwide network to identify Marine officers and senior enlisted members for this duty. Once assigned, these Marines' primary duties is to notify the next of kin of fallen Marines. Once notification is made, these Marines are responsible for follow-up visits to explain military benefits and to provide military honors if requested by the family. These assignments are some of the most difficult in the Marine Corps. Every Marine in this duty understands this is the very least they can do to honor the service of fallen Marines and help families deal with the loss of their loved one. "Honoring the Fallen" explains this process and why it is so important to those serving and their families
