SIR Branch 47 Board Meeting

Tamalpais Branch Zoom meeting from homes May 24, 2021

Meeting was called to order at 10:30 a.m. by Big Sir Doug Twitchell and a quorum was determined to be logged in.

Attendees: Doug Twitchell, Frank Ghazzagh, Jake Solomon, Alan Thomas, Bob Gonzalez, Will Kaefer, George Miller, Rick Coburn, and Jim Kleiser. Those absent were Bill Stewart and George Brown. Visitors were Bill Wickley and Carl Dawson.

Minutes from Board meeting of April 26, 2021 were moved for acceptance and passed.

Big SIR Report:

Big Sir reported that all items included in a monthly report would be raised under specific topics.

Little SIR Report:

The speakers scheduled for April 27 were Lisa Scarsella and Debbie Toizer on the topic *Myth Busting in Marin* (related to racial justice and prejudice in Marin). The topic generated controversy to the extent that a follow up Zoom meeting was scheduled a week later. Concerned membership was invited to discuss their observations on the subject with several participants attending and offering anecdotal information. This also resulted in discussion at the Board meeting as to the appropriateness of controversial subject matter for programs. The conclusion was reached that perhaps the two speakers from April 27th may not have "understood" SIRs as an audience. The program for May 25th will cover the Underground Railroad related to the Civil War era. The June meeting will cover the French Underground related to World War II. The speaker for July has cancelled.

Treasurer's Report:

There was no activity in May and all of the balances are the same as they appeared on the April report.

Committee Reports:

Jake Solomon reported and spoke on the current status of the nominating committee and stated three points: (1) the incumbent Board members who are leaving the Board have ably contributed their time and talents to the good of the Board (2) Will Kaefer in particular was noted to have contributed much and is thanked for sharing his considerable knowledge of SIR activity whenever needed (3) Jake was pleased to report that the slate of six officers and six directors has been completed to total the Executive Committee requirement of twelve members. Milestones to be completed are July for making the slate known to Branch 47 membership amounting to nomination, and for August to hold election. Detailed information will be released on future dates through Tamal Talk and individual notices to members.

Old Business:

Ron Kosciusko on eCommerce activity: Ron was not present so specific details are deferred. Discussion was raised on Google Drive for backups with further action deferred. The elimination of Drop Box was brought up with future consideration to follow. Further file transfers would have to be completed.

New Business:

Bob Gonzalez gave a report on the receipt status of Waiver/Vac forms. Out of 107 Branch members, currently 45 have not responded. It is difficult to plan for an opening meeting date when that many members have not yet complied with the SIR State requirement. Branch 47 does not want to be subjected to State closure if it is disclosed that many members are not yet in compliance. Doug said that he would call Members who have not yet sent in their completed forms. Doug stated that the monthly process of member telephone contact by the Board will be terminated.

The proposed "brown bag" July 14th picnic at Miwok Park was discussed. Board members raised several questions regarding logistics, consideration as to how inclusive should our outreach to guests be, and to what extent the Branch be open to subsidizing with beverages, table décor, etc. Since Kurt Heilman is coordinating the event, Doug suggested that Kurt be sent a letter to clarify logistical questions. Doug will pick up needed items from COSTCO and asked that the Board approve expenditures up to \$200.00. Doug said that Big Sir also has a discretionary \$100, so that amount coupled with the \$200.00 could be combined if \$200 is exceeded. Motion was made and seconded that Big Sir be authorized to spend up to \$200 for purchases, motion passed. No motion was necessary regarding the \$100.00.

Resuming operations at McInnis will need oversight from a Board member and Will Kaefer volunteered to fill the position. Will has worked closely in the past with Eric Jensen, McInnis Club Manager, and all felt that this will be an advantage to forming good negotiations. Jim Kleiser also volunteered to assist Will with formulating the opening and the Board membership is grateful to Will and Jim for their interest.

Next Branch 47 Board meeting is scheduled for June 21, 2021 with the possibility of meeting in the Board Room at McInnis Golf Park. Board members will be informed. The May meeting was moved for adjournment at 12:10 p.m.






