SIR Branch 47 Board Meeting

July 26, 2021

Meeting was called to order at 10:30 a.m. by Big Sir Doug Twitchell and a quorum was determined to be logged in.

Attendees: Doug Twitchell, Frank Ghazzagh, Jake Solomon, Alan Thomas, Bob Gonzalez, Will Kaefer, Rick Coburn, Jim Kleiser and George Brown. George Miller and Bill Stewart were absent. Visitors were Bill Wickley, Mark Rudy, Erick Young, Dee Steuver and Trevor Hughes.

Minutes from Board meeting of June 21, 2021 were moved for acceptance and passed.

Big SIR Report:

Big Sir reported that all items included in a monthly report would be raised under specific topics. The Board recognized a Branch 47 member who appeared and addressed his concern with expenditure of wine purchase. He was opposed to apportionment of his annual dues being directed toward wine purchase and the distribution of a bottle of wine to each member who will be present at the August 25th on-site meeting. After some discussion, Alan said that this issue had been previously raised about six years ago. At that time, the Board approved the purchase of Martinelli's cider, a non-alcoholic beverage that was then distributed to members who were given the option of accepting wine or a non-alcoholic beverage for birthday or other tribute. This previously observed remedy was again moved for acceptance by the Board, seconded and carried. The matter was considered closed by passage of the motion. As an aside, any member of SIR Branch 47 who is in good standing may be present at a Board meeting whether to observe or raise an issue. Issues should be first raised with the Big Sir for the purpose of inclusion with the agenda. Discussion will then take place when the item is reached on the agenda.

Little SIR Report:

Two speakers will be present for the July Zoom meeting entitled Carving Joy, Finding Peace. A recording will be available to the membership after its posting on YouTube. No speaker is planned for the on-site meeting scheduled for August 25th. The September program will be presented by Julie Syler based on her book The White Devil's Daughter, coverage of the slavery and virtual imprisonment of young Chinese women in San Francisco's Chinatown in the late 1800s and earlier years of the 20th century. There are no presentations scheduled beyond September.

Treasurer's Report:

Two expenditures were raised by Big Sir, picnic supplies of \$35.00 to \$40.00 and the wine purchase.

Committee Reports:

Slate of nominees was presented for July nomination, and for August to hold election at on-site meeting. Detailed information will be released on future dates through Tamal Talk and individual notices to members. At the present time, there is no designated Assistant Secretary and this is seen as incomplete coverage in the instance that the Secretary had to be absent. Secretary will attempt to remedy this matter to result in a complete Board.

Old Business:

With regard to Google Drive access for file backups, it is believed that all members who need access to the Google Drive should be skilled in this process. Big Sir said that ideally Google Drive access should be easy and he is willing to go to members' homes to impart the instructions to those in need.

- Bob Gonzalez reported that of our current membership of 103, 19 members still have not provided information that they have received COVID-19 vaccinations. Twenty-three members have not completed the waiver form. Tamal Talk or other means of communication should cover this matter so that full membership is apprised of its urgency and the potential for incomplete communication at future on-site gatherings will be minimized.
- The Branch 47 picnic held at Miwok Park on July 14th was acclaimed to be a success. The possibility of the "bring your own meal" for future events was raised. Any event designated to be a SIR event will be covered by SIR insurance.
- Long-standing member Chris Lewis has moved to Southern California. His status is now member emeritus. He will no longer be notified of future events and will not be included in active member tabulation.

The slate of officers for the 2022 term should be sent to all members by written communication. The secretary bears the responsibility for forwarding a Form 20 to State SIR body in August informing whether Branch 47 election of officers has or has not taken place.

New Business:

For on-site August luncheon planning, care must be taken to cover check-in table, covid/waiver verifications, money drawing, greeter(s), book library, PA system setup and possibly other components to ensure a smooth resumption of our monthly on-site luncheon and program.

Meal tickets will be available since the luncheon meal will now include more choices. Color coding of tickets and numbering tickets for drawings will result in revised procedures for increased options. Membership will be apprised of these revisions in a letter to soon go out.

- Big Sir will be out of the country for the September board meeting and luncheon. Little Sir will preside at both events. Big Sir recommended that Board have a Zoom meeting prior to the August luncheon.
- July 26, 2021 meeting was moved for adjournment at 11:53 a.m. The next board meeting will take place on Monday, August 23, 2021 at 10:30 a.m. Notification will include either Zoom or on-site at McInnis Golf Club.


