This RSVP system will greatly aid the chairmen of our special events and Luncheons. Below are the procedures involved in registering for the luncheons on the website. (Please note that if you do not have a computer or cannot use one you can always make a reservation by calling 415 881 7477 and leaving a voice message with your name, Member Number, and menu choice.)

3.a. Go to www.sir47.org

At the **Home** screen, put your cursor on **Calendar** so that the **Event Calendar** appears. Click on the **Event Calendar**.

Depending upon the speed of your internet connection, the list of Events may take a moment to load. The **October Luncheon** should appear on your screen. Click on **RSVP Now**.

This will take you to the Registration or **Ticket** Screen.

- 3.b.If you are not going to be able to attend, click on **CAN'T GO**. Complete the required information, your name and email address, and then click **FINISH**. You should receive an email confirming that you will NOT be able to attend the luncheon. (It is important to let us know if you cannot attend. We need to inform McInnis of the number of lunches required.)
- 3.c. If you can attend, click on GOING. . Complete the required information, your name and email address, This should take you to the Attendee Registration screen. (Attendee equates to MAIN GUEST If you bring a guest, at the -1+ click + to 2 and each of you will be asked for name, email and menu choice for you and your guest.

Select the meal you want. Click FINISH to complete your reservation.

You should receive a confirmation email shortly afterward from Wordpress not Branch 47.

NOTE: If you want to cancel or change a reservation, add a guest or change a meal, the system provides for all these functions.

The new procedures are only meant to enhance our legacy systems as they are integral to ensuring we have an ability to serve our members. In the event, for instance, that the website is unavailable we will have a legacy process that works to continue.

**SIR Branch 47 Board Meeting** Tamalpais Branch Zoom Meeting from homes August 24, 2021

Meeting was called to order at 10:30 a.m. by Big Sir Doug Twitchell and a quorum was determined to be logged in.

Attendees: Doug Twitchell, Frank Ghazzagh, Jake Solomon, Alan Thomas, Bob Gonzalez, Will Kaefer, Rick Coburn, Jim Kleiser, George Miller and Bill Stewart. George Brown was absent. Visitors were Bill Wickley, Mark Rudy, Erick Young, Mark Bosch, Alan Lutsky and Ron Kosciusko.

Minutes from Board meeting of July 26, 2021 were moved for acceptance and passed.

#### **Big SIR Report:**

Big Sir reported that all items included in a monthly report would be raised under specific topics.

Minutes will be transmitted to full membership but only on approval of finalized minutes by the Board. Members not sitting on the Board may attend Board meetings, but only Board members can move and pass motions, issue completed minutes or revise the minutes in any way. Policy is now in effect whereby minutes of a particular month will not be published until the Branch Executive Board has reviewed the minutes of the previous month. On the completion of the Board review, a motion to approve the minutes will be passed, discussion may follow, and the Board will approve the motion to accept if all are in accord. This is to allow for alterations by the Board but further changes subsequent to the publishing of the minutes will not be permitted. Hypothetically, the September Tamal Talk newsletter will include the minutes of the July meeting and the October TamalTalk will include the minutes of the August meeting.

#### Little SIR Report:

The September program will be presented by Julie Syler based on her book The White Devil's Daughter, coverage of the slavery and virtual imprisonment of young Chinese women in San Francisco's Chinatown in the late 1800s and earlier years of the 20<sup>th</sup> century. The October meeting will also include a scheduled speaker.

#### Treasurer's Report:

Current status of treasury includes sum of \$8,959.37 in combined accounts. Wine expenditure and picnic expenditures are on the books.

#### **Committee Reports:**

Jake Solonon spoke on the election process to take place at the August 25<sup>rd</sup> meeting. New officers are to be elected at the meeting including requests for nominations from the floor. Swearing in will take place at a later date. The number of directors cannot exceed six. The slate of officers was made available to the Board and will be made available to members present at the luncheon.

Bowling is on hold with major roof damage at bowling alley.

Bocce will be held in Sonoma with Frank Ghazzagh heading up the activity.

#### **Old Business:**

Big Sir said that ideally Google Drive access should be easy and he has gone to members' homes to impart the instructions to those in need. New participants can log in with a new password and the process is not viewed as difficult.

Bob Gonzalez reported that about fifteen members do not have branch closure on vaccination record on file or signed waiver. Fifty-one members will be attending the August 24<sup>th</sup> luncheon. Branch 47 has not been charged in the past by McInnis if the number projected for attendance had exceeded actual number that attended. Will Kaefer volunteered to check vaccination or waiver information for members who do not have completed information on file and will be conducted at the entrance.

All components of the luncheon were scheduled to be in place as well as the members who cover

specific responsibilities. The call-in process went well and the Board members expressed their satisfaction with receiving an e-mail acknowledgement. Thanks are extended to Rick Coburn for ably handling this task.

All wine will be set in place at the luncheon tables and the non-alcoholic beverages will be announced as on hand if member (s) want to make an exchange.

Those wishing to make a reservation for an upcoming event are referred to SIR47.org. Board members are encouraged to make reservations for the September 28<sup>th</sup> luncheon so everyone is on board with this process. To address the ambiguity of "guest", the member signing on is one guest and each added guest continues the count. If a member brings a spouse to an event, that is two guests. Guests are added on with a "+" symbol. It is Ron's hope to end up with one event calendar; a single calendar and a standardized notification system should simplify the whole process.
