Zoom Meeting from homes

October 26, 2021

Meeting was called to order at 10:30 a.m. by Big Sir Doug Twitchell. A quorum was determined to be logged in.

**Attendees:** Doug Twitchell, Frank Ghazzagh, Jake Solomon, Alan Thomas, Will Kaefer, Rick Coburn, Jim Kleiser, Bill Stewart and George Miller. George Brown and Bob Gonzalez were absent. Visitors were Mark Bosch, Carl Dawson, Ron Kosciusko, Alan Lutsky, Bill Wickley and Mark Rudy.

Minutes from Board meeting of September 2021 were moved for acceptance and passed.

### **Big SIR Report:**

Leadership training may be scheduled with no firm date yet.

### **Little SIR Report:**

November speaker will be Bob Menken who had ties with many of the known bands and performers; his talk is entitled: *The Music Never Stopped*. There are speakers scheduled up to May 2022.

### **Treasurer's Report:**

State SIR waived the 4<sup>th</sup> quarter assessment. Signature cards will be revised with all officers appearing in person will have financial responsibilities

### **Committies:**

None reported

### **Old Business:**

Google Drive: it was noted that the program will not recognize a new user's computer; Doug is the primary signer and would computer have to "approve" of the new user for that user to proceed in Google on his own. Doug said another primary signer should be designated.

It is uncertain if intention of delinquent members will be provided by such members, but self-addressed envelopes will be placed at table places for convenience of all members present at future meetings for submitting dues.

Fifty members and speaker as +1 show that fifty-one lunches will be served on October 26<sup>th</sup>.

More wine and Martinelli's cider will need to be purchased prior to November meeting.

Ron K. spoke on updates regarding the web-based reservation system. Some responses indicated that members did not receive e-mail confirmations. The system may need further adjustment.

Discussion involved the necessity for bringing our video/sound equipment to meetings which is kept in a portable case; result was that our equipment should be brought to meetings in the event the house system should be disrupted.

An issue was raised regarding the matter of entertainment at the Holiday dinner. Oposing views were taken that entertainment costs should be part of the dinner fee, and the contrary thought was that a more professional presentation should be made which would likely involve funds external to the dinner charge. After much discussion, a vote was taken which was found favorable to hiring a polished duo to provide background and dance music during and after the dinner. Some considerations arose from this discussion which follow:

The hire of outside entertainment is a one-time event for 2021 and does not set precedent.

The matter should be revisited in early 2022 as a debriefing to see if we will proceed in future years as in 2021 or if the event should revert back to a more modest presentation.

Costs incurred for the Holiday and other events may or may not currently come from guest reservations. It is suggested that perhaps costs should receive more scrutiny in the future.

The policy that all event charges must be built into the dinner fee may need rethinking and the matter should be revisited in early 2022.

It was moved, seconded and passed that membership dues remain at \$30.00 per member for calendar year 2022.

### **New Business:**

Ron K. asked that a committee be appointed to assist in removal of obsolete items from the SIR Branch 47 website. All upcoming officers for 2022 must be in attendance for the November meeting for the installation ceremony.

Eric Young will again oversee the production of the roster book for 2022 but since he will be filling the post of Big Sir, his further involvement on this project perhaps should revert to another member.

October 25<sup>th</sup> meeting was moved for adjournment at 11:30 a.m. The next Branch 47 meeting will take place on Monday, November 22, 2021 at 10:30 a.m. Zoom process will continue.

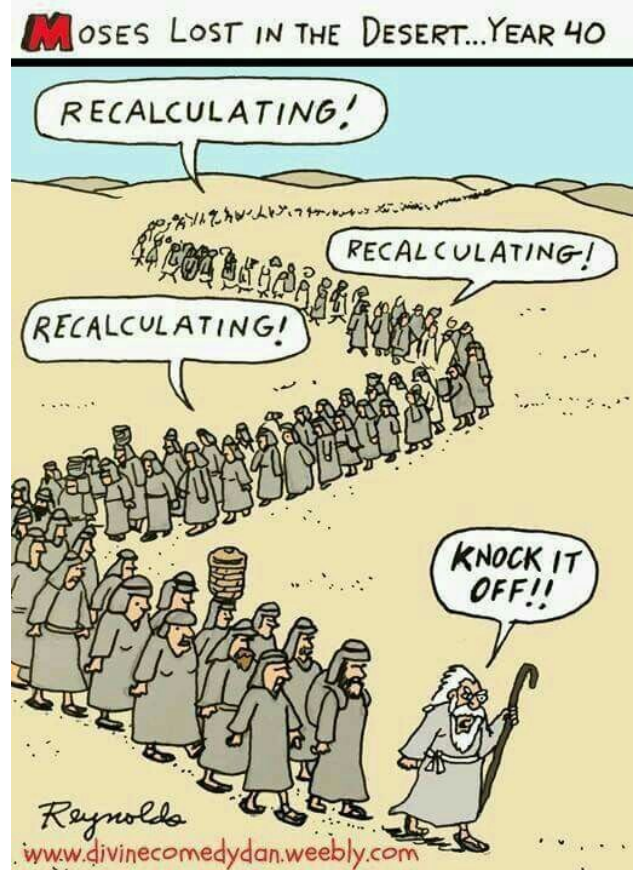

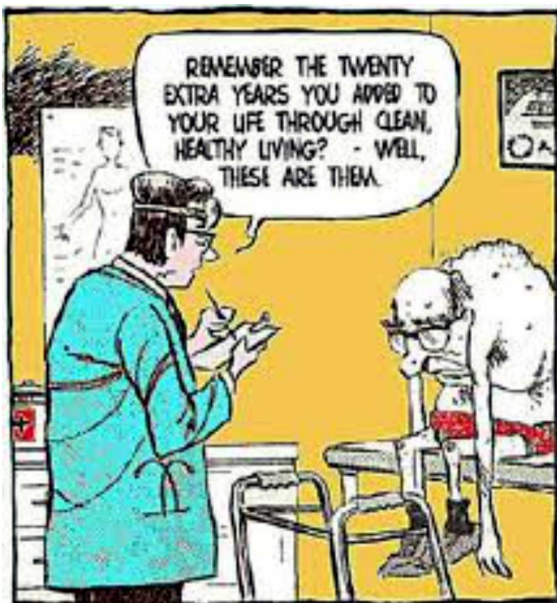
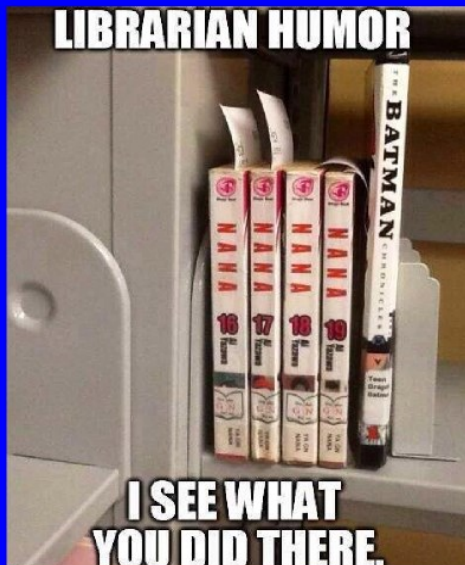
